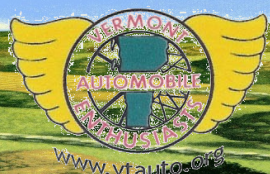

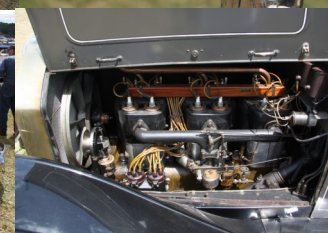

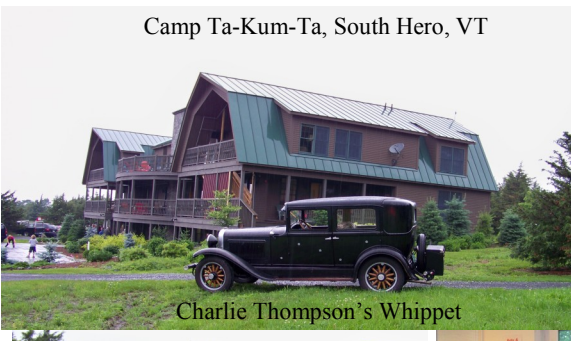

My wife and I were having lunch there when this old Rolls pulled up in front. I remarked to the driver that I had a friend in Morrisville Vermont who had owned a similar car and he said that he had bought it from *Adrian's* estate. Small World!

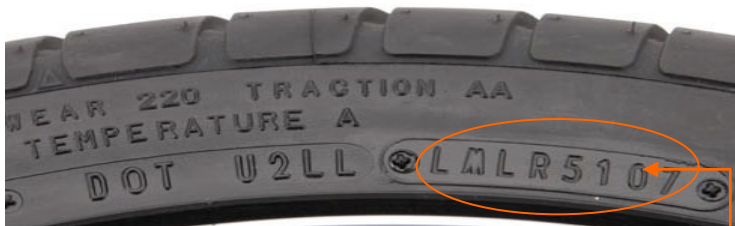
*Adrian* and I were friends in the early 50's (last century) when I worked summers at the state park at Lake Elmore. He had a brand new 53 MG TD which blew the doors off (at least in the corners) my model A and later 41 Ford convertible which he helped me overhaul after I burned the valves on one cylinder and lost all compression.

At that point neither of us had ever done extensive automotive repairs but we took the engine out and redid everything. We didn't realize that you needed to lube the reassembled bearings so when we couldn't get the overhauled engine to turn over on the starter, loaded 5 people into the car so the rear wheels wouldn't skid, pushed the car up to 35 mph and popped the new clutch. Eureka; a success!

Unhappily shortly thereafter on a trip up the Mt Mansfield toll road to pick up dates who worked at the old hotel at the summit and then on to St Albans Bay for a dance I hit a tree on the return and pretty well totaled the car. I couldn't part with the engine and eventually sold it to another guy who installed it in his Ford.

Adrian was responsible for my long time interest in antique British sports cars. I have a 56 Austin Healey, 63 MGB, 68 XKE Jaguar.
